## 2025 Sacramento Chapter Corporate Partnership Benefits Frequently Asked Questions

Question	Answer
When do my Corporate Partnership benefits expire?	December 31 <sup>st</sup> 2025
Do all company/agency employees receive member benefits when you become a Corporate Partner?	No, please refer to the 2025 Sacramento Chapter Corporate Partnership Benefits table above to see the number (if any) of individual WTS International memberships included with each level of Corporate Partnership.
Can I change an individual designated to receive a WTS International membership part of the way through the year?	No, once an individual has been designated to receive a WTS International membership the membership cannot be transferred.
Is there a difference between a WTS International membership and a WTS Sacramento membership?	No, the memberships are one and the same. As a member of WTS International, an individual receives membership benefits offered by all WTS chapters.
What if an individual that I want to assign a Corporate Partnership provided membership is already a WTS member?	The Corporate Partnership provided membership will extend an existing membership by 12-months. For example, if you assign a membership to an individual who has an existing membership that is set to expire on 6/1/25, their membership will be extended through 6/1/26.
What if I don't want to assign all of the allotted memberships to specific individuals?	Corporate partners have the option to receive an additional twelve (12) non-member lunch program vouchers in lieu of any one (1) membership.
Will WTS Sacramento repost content from Corporate Partner social media pages on their social media accounts?	Yes! If the content is appropriate, nonpartisan, and non-controversial, WTS Sacramento is happy to repost Corporate Partner content. If you would like your information reposted, please send a direct message to the WTS Sacramento account on the desired social media platform.
What is considered a "special event"?	WTS Sacramento hosts two events that we consider to be "special events". These events are the Annual Awards and Scholarship Dinner and the Cruisin' the Catwalk Fashion Show.
What does "locked in early bird pricing" mean?	For Platinum (Local) Corporate Partners, we will honor the early bird price beyond the early bird period up until late registration pricing begins. These locked in prices apply to purchases of a full table at the Annual Awards and Scholarship Dinner and a full row at the Cruisin' the Catwalk Fashion Show. We will honor these discounted prices for as long as full tables and rows are available for these events. Extended early bird pricing does not apply to individual, half row and half table ticket sales.
When should the lunch program vouchers be used?	The lunch program vouchers can be redeemed for free attendance at a single lunch program for individuals who are not WTS members. Individuals who are already WTS members get to attend the lunch programs for free, so there is no benefit to registering them using a voucher. One individual can be registered per voucher. The lunch program vouchers can be used for both virtual and in-person attendance.
